

## CONSENT TO BROADCAST/PUBLISH AND ASSIGNMENT OF COPYRIGHT

Thank you for contributing an audio/image/video file to the National Council of Teachers of English ("NCTE").

As a condition of broadcast/publication, it is essential that you grant us all rights, including the copyright, for the Contribution. The terms "publish" and "publication" as used herein shall mean and include every means by which the Contribution or any form of reproduction of the Contribution may be issued, distributed, or otherwise made available to the public, including electronic and print means. Accordingly, the following terms of publication are submitted for your consideration:

APPROVAL AND ACCEPTANCE: We mutually agree that publication/distribution of the Contribution is contingent upon its acceptance by NCTE and upon its meeting NCTE editorial standards.

COPYRIGHT ASSIGNMENT: Whereas NCTE undertakes to publish the Contribution as above, and whereas you desire to have the Contribution so published, now, therefore, you grant and assign to NCTE for its exclusive use the entire copyright for the Contribution. The copyright consists of any and all rights of whatever kind or nature now or hereafter protected by the copyright laws of the United States and of all foreign countries in all forms of communication, and NCTE shall be the sole owner thereof. NCTE, in turn, grants you the right to republish the Contribution in any work consisting of your own writing, subject only to notifying NCTE of your intent to do so and to the granting of proper credit in the work to the original publication of the Contribution by NCTE. In such case NCTE shall waive its customary permission fee.

WARRANTY: You warrant that the Contribution is original with you; that it contains no matter which is libelous or is otherwise unlawful or which invades individual privacy or infringes any proprietary right or any statutory copyright; and you agree to indemnify and hold NCTE harmless against any claim or judgment to the contrary. Further, you warrant that you have the right to assign the copyright to NCTE, and that no right protected by copyright to the Contribution has been previously assigned. It is understood that the copyright to the Contribution has not been registered with the United States Copyright Office, but in the event that such registration has taken place, you will promptly transfer the copyright to NCTE.

PREVIOUS PUBLICATION AND PERMISSION: You warrant that the Contribution has not been published elsewhere in whole or in part and that no agreement to publish the Contribution or any part or version thereof is outstanding.

REQUESTS TO REPRINT: As owner of the copyright to the Contribution, NCTE has the sole authority to grant a request to reprint the Contribution, or any parts thereof. However, pursuant to NCTE's Permission Policy then in effect, NCTE may attempt to obtain your approval should NCTE receive a request to reprint all or any portion of the Contribution for commercial use. This attempt shall include a letter sent to your last known address outlining the use, the proposed fee, if any, and allowing 30 days for a response. Failure to respond in the stated time period will constitute consent. Fees will be handled according to the NCTE Permission Policy then in effect.

COMPENSATION: You shall receive no royalty or other form of compensation, except for any permission fees which you may receive as noted above.

PROMOTION: I authorize NCTE to use my name, likeness, photograph, and bibliographic data in connection with the use and promotion of the Contribution.

If the foregoing terms are satisfactory, please sign and date this agreement and return one copy in the enclosed business reply envelope. The second copy is for your records.
