#### **English Composition I: Achieving Expertise Sample Peer Feedback: Formative**

I think they are sufficient and the first paragraph to illustrate this picture, in particular, is effective for readers who might be unfamiliar with Brazilian culture to understand your analysis. However, I would like to see more analysis about what class the people who exploit laborers belong to, the social status of Afro-Brazilian descendants in the Brazilian communities, why African-Brazilian have settled down in Brazil. You also should analyze a white worker with an empty bucket who has the same ethnic feature as the black laborer you mentioned. If they are delivered, I suppose readers will see real aspects of the Brazilian society more from the picture. (Discussion Board)

You shows summary in the very first paragraph by including quotes about practice but there are no examples for the evidence, You can explain more about practice and its entails and your understanding about the text is shown by second paragraph where you explained it as climbing a

large mountain, you must take one step at a time and contemplate the next move. I think there are more evidence and explanation required for the summary.

You have defined practice quite well in your paragraph of practice is a treasure... but there aren't sufficient examples to define or refers other key terms So, Integrate them with your text

In paragraph where you show that coyle's idea is irrelevant at times doing skydiving and bungee jumping clearly limiting his main claims

It is not very detailed though, so emphasizing the importance and value of the painting might help later when discussion about origin of painter's talent begins.

The Annotated Bibliography is supposed to help us write the essay, but is not enough for a draft. Choose one type of disease and focus on one case only, Art Buchwald for example. If too many, you cannot follow anymore. You stop and wonder: what was the essay about?

Leave this part: "In my essay, I will also analyze the quality of life of elderly couples in both industrialized countries and undeveloped countries. Is there a long term care facility a better place to live..." too many points to cover in only one essay.

Your title "Quality of Life during an Illness" is too general and not strong enough. You can make a long title. The title should say it all, to know what to expect from your essay. It is not necessary to write "area of expertise" or "potential case study," I expected a full text. Be more confident and concise about your subject. Also, you do not need to write "Potential Case Study: Knowing the ins and outs of the disease, Keeping the good humor, Not talking about the ailments, Companionship of relatives and friends, Preparing to the worst." This was just an exercise Prof. Comer suggested to help us identify our main argument. Or at least this was my understanding. Forgive me if I am wrong.

### Did you find the introduction effective? If so, please describe what features make it effective. If not, make a few suggestions for how the writer can improve it.

"Very often we do not appreciate the everyday life and waste precious moments in arguments or silent code with the members of our family. The point to make in this essay is to be more conscientious about life being healthy, and life being ill." Like I said earlier, you want to focus on one thing only: living with a person having a terminal stage, or living with the disease from the ill person's point of view. If you work hard, you can make an excellent essay, just focus the reader on one single idea. It is up to you now.

There is no structure, and it is a pity. No conclusion, just a list of things to do. Please review videolecture 2.3 What is a Draft, APA style, samples of papers and workshops suggested. Remember: strong title, catchy introduction, good conclusion, make a good essay, not plans, ideas about what you are going to do. A draft should be almost like a final project.
